MIRACLE FLIGHTS IS A NATIONAL CHARITY THAT PROVIDES FREE COMMERCIAL AIRLINE TICKETS FOR U.S. RESIDENTS IN NEED OF DISTANT MEDICAL CARE NOT AVAILABLE IN THEIR OWN COMMUNITIES.

WITH THE COST OF AIR TRAVEL CONTINUALLY RISING, IT IS NO SURPRISE THAT 83% OF FAMILIES EXPERIENCE FINANCIAL HARDSHIP FROM MEDICAL EXPENSES. IN FACT, A FULL 61% OF BANKRUPTCIES OCCUR BECAUSE OF MEDICAL EXPENSES, INCLUDING TRANSPORTATION COSTS. WHILE INSURANCE MAY COVER ACTUAL TREATMENT, IT RARELY COVERS THE COST OF TRAVEL. AS A RESULT, SOME PATIENTS WILL GO UNTREATED OR MISDIAGNOSED, SIMPLY BECAUSE THEY CANNOT AFFORD TO GET TO THE EXPERTS WHO CAN EFFECTIVELY TREAT THEIR CONDITION.
