## DISCOVERY OF FINANCIAL IRREGULARITIES IN NOVEMBER 2024

THE ORGANIZATION'S BOARD OF DIRECTORS (THE "BOARD") ESTABLISHED AN AUDIT COMMITTEE (THE "AUDIT COIMMITTEE"). IN NOVEMBER 2024, THE ORGANIZATION'S AUDITOR IDENTIFIED WHAT APPEARED TO BE AN OUT OF CYCLE, ADDITIONAL PREMIUM PAYMENT OF \$257,000 TOWARDS THE POLICY PAID ON NOVEMBER 14, 2023.

WHEN THE NOVEMBER 14, 2023 PAYMENT WAS BROUGHT TO THE AUDIT COMMITTEE'S ATTENTION, A MEMBER OF THE AUDIT COMMITTEE ("JJ") MADE AN INQUIRY WITH SYMETRA AS TO THE NEED FOR THE EXTRA PREMIUM PAYMENT. IN HIS DISCUSSIONS WITH SYMETRA, JJ DISCOVERED THAT:

(1) ON AUGUST 16, 2023, BROWN HAD PREVIOUSLY DIRECTED SYMETRA TO INITIATE A LOAN AGAINST THE POLICY (THE POLICY LOAN) FOR \$260,000. THE POLICY LOAN WAS INITIATED BY BROWN, ON MIRACLE FLIGHTS LETTERHEAD, IN HIS AUTHORITY AS THE "SOLE EXECUTIVE OFFICER OF MIRACLE FLIGHTS".

(2) ON AUGUST 17, 2023, SYMETRA PAID POLICY LOAN PROCEEDS IN THE AMOUNT OF \$259,990 (THE "LOAN PROCEEDS"), TO BROWN IN THE FORM OF A CHECK MADE PAYABLE TO THE ORGANIZATION.

(3) ALTHOUGH THE ORGANIZATION ALREADY HAD A CHECKING ACCOUNT IN ITS NAME WITH THE BANK OF NEVADA, WITHOUT INFORMING THE BOARD, BROWN OPENED UP A NEW BANK ACCOUNT IN THE ORGANIZATION'S NAME WITH A LOCAL CREDIT UNION (THE "UNDISCLOSED ACCOUNT"). BROWN DEPOSITED THE LOAN PROCEEDS INTO THIS UNDISCLOSED ACCOUNT, BROWN HAD SOLE CONTROL OVER THIS UNDISCLOSED ACCOUNT, AND THEREFORE ALL AMOUNTS DEPOSITED INTO THE ACCOUNT WERE AT ALL TIMES AVAILABLE TO BROWN FOR HIS OWN PERSONAL BEBENEFIT.

(4) BROWN SUBSEQUENTLY WITHDREW AT LEAST A SUBSTANTIAL PORTION OF THE LOAN PROCEEDS FROM THE UNDISCLOSED ACCOUNT TAKING CONTROL OF THE LOAN PROCEEDS FOR HIS OWN, PERSONAL BENEFIT.

(5) ON OR ABOUT DECEMBER 8, 2023, A CASHIER'S CHECK IN THE AMOUNT OF \$6,519.38 WAS ISSUED FROM THE UNDISCLOSED ACCOUNT AND PAID TO SYMETRA AND APPLIED TOWARDS REPAYMENT OF THE POLICY LOAN.

AT NO POINT HAD BROWN DISCLOSED ANY OF THE FOREGOING ACTIONS TO THE BOARD.

## STEPS TAKEN BY THE BOARD TO RECOVER ORGANIZATION ASSTES

FOLLOWING THE ORGANIZATION'S DISCOVERY OF BROWN'S ACTIONS, THE ORGANIZATION PROMPTLY TOOK APPROPRIATE ACTION, PLACING BROWN ON ADMINISTRATIVE LEAVE EFFECTIVE DECEMBER 13, 2024, PENDING AN INVESTIGATION BY AN OUTSIDE LAW FIRM HIRED IN DECEMBER 2024.

THE INVESTIGATION BY THE LAW FIRM AFFIRMED BOTH (1) BROWN'S INITIATION OF A POLICY LOAN AND SUBSEQUENT USE OF THE RESULTING LOAN PROCEEDS FOR HIS OWN PERSONAL USE, AND (2) BROWN'S DIRECTION OF THE REPAYMENT OF THE POLICY LOAN WITH ORGANIZATION FUNDS, EACH OF WHICH WAS AN UNAUTHORIZED TRANSACTION INITIATED BY BROWN WITHOUT ANY KNOWLEDGE OF, OR NOTICE TO, THE BOARD.

OVER THE COURSE OF THE NEXT SEVERAL MONTHS, THE ORGANIZATION AND BROWN HAD MULTIPLE MEETINGS AND DISCUSSIONS, THROUGH COUNSEL, DESIGNED TO RECOVER BROWN'S UNAUTHORIZED POSSESSION OF THE ORGANIZATION'S ASSETS,

AND REACH A RESOLUTION REGARDING BROWN'S EMPLOYMENT. IN AUGUST 2025, THE BOARD NOTICED A SPECIAL MEETING FOR THE INVOLUNTARY TERMINATION OF BROWN'S EMPLOYMENT. THE DAY BEFORE THE MEETING, BROWN VOLUNTARILY RESIGNED.

APPROXIMATELY ONE MONTH LATER, BROWN RETURNED \$263,519.18 TO THE ORGANIZATION (AN AMOUNT EQUAL TO THE SUM OF (I) THE \$257,000 BROWN DIRECTED BE PAID TOWARDS THE POLICY ON 11/14/2023 PLUS (II) THE PAYMENT OF \$6,519.38 ISSUED TO SYMETRA FROM A CASHIER'S CHECK DRAWN FROM THE UNDISCLOSED ACCOUNT THAT, WITHOUT BOARD KNOWLEDGE, HAD BEEN OPENED BY BROWN IN THE ORGANIZATION'S NAME.

IN THE INTERIM, THE BOARD OF DIRECTORS HIRED A CONSULTANT TO PROVIDE LEADERSHIP FOR THE ORGANIZATION, WHILE IT COMMENCED A SEARCH FOR A REPLACEMENT CEO. AFTER A MONTHS' LONG SEARCH, THE BOARD OF DIRECTORS HIRED A NEW CEO ON NOVEMBER 5, 2025. THE ORGANIZATION IS WORKING WITH ITS PROFESSIONAL ADVISORS TO REVIEW, UPDATE AND STRENGTHEN INTERNAL CONTROLS AND PROCESSES, TO PREVENT FUTURE UNAUTHORIZED TRANSACTIONS, IN ADDITION TO RESTRUCTURING WITHIN THE ORGANIZATION.

**TREATMENT OF ORGANIZATION ASSETS CONTROLLED BY BROWN**

AT ALL RELEVANT TIMES, BROWN'S STATUS AS AN OFFICER OF THE ORGANIZATION MEANT BROWN WAS A "DISQUALIFIED PERSON" UNDER CODE SECTION 4958(F)(1) WITH RESPECT TO THE ORGANIZATION.

THE ORGANIZATION CONSIDERS BOTH (I) THE UNAUTHORIZED LOAN BROWN DIRECTED BE MADE FROM THE POLICY IN THE AMOUNT OF \$259,990 IN AUGUST 2023 AND (II) THE UNAUTHORIZED PAYMENT OF \$257,000 BROWN DIRECTED BE PAID BY THE ORGANIZATION TO THE POLICY IN NOVEMBER 2023 (TO REPAY THE UNAUTHORIZED LOAN) AS SEPARATE EXCESS BENEFIT TRANSACTIONS UNDER SECTION 4958(A)(1).
